Official Rules 2023 Tread Lightly! Protect the Fun Giveaway

You will receive ten (10) entries for a \$25 membership level; twenty-five (25) entries for a \$50 membership level; sixty (60) entries for a \$100 membership level; and one-hundred and eighty (180) entries for a \$250 membership level. Once your membership is complete you will automatically receive the number of entries based on the membership level. Entry Method #3 - Upgrade Your Membership. If you are an expired/inactive member you can enter through this method by visiting https://treadlightly.org/join and follow all instructions to complete the renewal using the membership form, including upgrading your membership level and processing payment ("Membership Upgrade Entry"). You will receive thirty (30) entries for upgrading your \$25 membership to the \$50 membership level; seventy-five (75) entries for upgrading your \$50 membership to the \$100 membership level; and two hundred (200) entries for upgrading your \$100 membership to the \$250 membership level. Once your upgraded membership is complete you will automatically receive the number of entries based on the upgraded membership level. If you are a current member and wish to upgrade, your expiration date will remain the same as when you originally joined. If you are an expired member that would like to upgrade, your join date will be updated to the date that you renewed your membership. You can only upgrade once during the Sweepstakes Period.
